Invited by the new Czech Republic Presidency of the European Commission and the Wild Europe organization, Chris Mahon attended the Wilderness and Large Natural Habitat Area Conference in Prague in May, on behalf of IUCN UK. This conference brought together 250 delegates interested in developing policy around wilderness protection and large natural area restoration. Opened by ex-President Vaclav Havel and EU environment minister, Ladislav Miko, the conference developed a “Poselstvi (message) from Prague”, which provides a way forward to implementation of wilderness protection and restoration. ## Overseas Territories – Cayman Island Conference Making the Connections

Key outcomes from this recent UK Overseas Territories (UKOT) conference in the Cayman Islands are as follows:

1. The 'environment' must be integrated into all sectors of learning and training.
2. Valuing ecosystem services, while challenging, can be a highly effective mechanism for habitat protection.
3. It makes financial sense to tackle invasive species issues sooner rather than later.
4. A positive and effective dialogue must be maintained with Her Majesty's Government (HMG).
5. The status of UKOTs within HMG needs to be enhanced, potentially through the nomination of a dedicated junior minister.
6. The mobilization of local volunteers is an effective means of resourcing, engaging and empowering people and biodiversity.
7. UKOT's are and should be encouraged to continue to tackle individually and collectively the effects of climate change.

## Working with IUCN Commissions – co-optees from CEC and WCPA.

In May, WCPA held its annual steering committee (SC) meeting outside Quito, Ecuador. Nigel Dudley attended the meeting as the chair for Capacity Development issues within WCPA. Key outcomes included:

1. Input into the Convention on Biological Diversity's (CBD) review on status and future of its Programme of Work on Protected Areas (PoWPA). WCPA, in cooperation with other IUCN commissions, is planning a 'Futures' workshop in South Korea in September, to help to set the agenda for four regional POWPA review meetings in late 2009 (the CEE region workshop will be held on the Island of Vilm, Germany in late November). The workshop will review policy input to the next CBD SBSTTA meeting, which will in turn make recommendations on the future of PoWPA to the Conference of Parties in Nagoya, Japan in October 2010.
2. One day of the SC meeting was held jointly with the CEC to plan how the two commissions could work more closely together, including identification of possible liaison regarding publicity and the development of courses
3. The SC also reviewed the work of the WCPA for 2009 and 2010, including development of an intergenerational programme to encourage more young professionals into the commission.

In cooperation with the WCPA Europe Regional Chair, Dr. Stig Johansson ([stig.johansson@metsa.fi](mailto:stig.johansson@metsa.fi)) and Chris Mahon, of the UK Committee, have agreed to be contact points for UK WCPA members. Would there be interest in holding a WCPA UK members' meeting in the autumn to input into the POWPA discussions

and other issues relevant to WCPA? The meeting would be self-funded but we would need a kind organisation to donate a venue and refreshments. Please let us know if you would be interested in attending, offering a venue and/or your thoughts on content, or on any other issues related to WCPA, by contacting Sue Stolten or Nigel Dudley.
